#### PROCEDURE TO BE FOLLOWED TO REQUEST ACCESS TO THE RECORDS:

Should you wish to access records of OMIGSA, you should:

- Complete the prescribed FORM C as contained in the Regulations to the Act and available on www.doj.gov.za
- Send the completed application via post, fax or email to the Information Officer Old Mutual Investment Group (South Africa) (Pty) Ltd at the address below.

The Information Officer will process your request and inform the requestor of the fees (if any) he/she has to pay and of the further steps that will follow in the processing of the request.

**Note:** Requesters must note that all of the information on the request form should be provided to the satisfaction of the Information Officer, failing which the process will be delayed until such time that the information is complete. The time periods prescribed by the Act will not commence until such time as the Information Officer is satisfied that all pertinent information is complete.

Access to certain records may be denied on the grounds set out in the Promotion of Access to Information Act. No 2 of 2000. Mandatory grounds for refusal include, but are not limited to:

- Information for the protection of the privacy of a person;
- Information for the protection of the commercial and/or confidential information of third parties;
- Information privileged from production in legal proceedings;
- Commercial information of OMIGSA;
- Research information:
- Information which can engender the safety of an individual.

Should the request for information be refused, the requester may lodge a written appeal to the Chairman of the Board of Directors of OMIGSA, within 30 calendar days from date of refusal.
